



SUMMARY RECORD OF LACAC-CAAS ROUNDTABLE FOR DIRECTORS-GENERAL

The Latin America Civil Aviation Commission (LACAC) and Singapore coorganised the LACAC-CAAS Roundtable for Directors-General (DGs) on air travel recovery on 14 December 2021. This is the second year that LACAC and Singapore have partnered on this initiative, providing a valuable touchpoint for engagement between LACAC, Singapore and Senior Management of LACAC Member States.

Objectives

- 2 The objectives of the LACAC-CAAS Roundtable for Directors-General are to:
 - Provide a platform for LACAC DGs to exchange experiences and best practices as aviation activities resume.
 - Discuss strategies, considerations and challenges in reviving aviation.
- Mr Armando Daniel Lopez, LACAC President and Mr Han Kok Juan, DG, Civil Aviation Authority of Singapore (CAAS) gave opening remarks. Mr Bernard Lim, Senior Director (International Relations and Security), Ministry of Transport, Singapore, co-moderated the session with Ms Alexandra Palomino, Coordinator of International Affairs and Aviation Policy, Special Administrative Unit for Civil Aeronautics, Colombia. In total, DGs and senior officials from 17 LACAC Member States and Singapore participated in the roundtable session, as shown in Annex A.

Key Takeaways

Sharing on Vaccinated Travel Lanes

4 Mr Han Kok Juan, DG, Civil Aviation Authority of Singapore (CAAS), shared Singapore's considerations and experiences on Singapore's Vaccinated Travel Lanes (VTLs). Country-based risk management approach, vaccination and testing form the three key pillars for Singapore's VTLs. This approach allows Singapore to reopen borders and revive air travel while balancing public health needs. Singapore has implemented VTLs with more than 20 countries to allow 2-way quarantine free travel for vaccinated travellers.

Considerations and Approaches to Air Travel Recovery

The roundtable discussed States considerations and approaches towards air travel recovery. LACAC Member States have taken steps to recover a significant portion of pre-COVID-19 air traffic. The approaches to air travel recovery differ across States, with a variety of measures taken to mitigate COVID-19 risks such as digital health





declaration, travel insurance, COVID-19 testing and differentiated treatment for vaccinated and unvaccinated travellers.

Challenges to Air Travel Recovery

The roundtable highlighted the challenges that States are facing amidst the pandemic, such as mental health and morale issues faced by aviation community. The COVID-19 pandemic and decline in air travel have led to concerns about livelihoods and fatigue. The roundtable acknowledged that it would be key to look after the mental health and morale of aviation workers.

Coordination and Cooperation

The roundtable acknowledged the need for effective coordination between CAAs and industry. States should work together to achieve harmonisation of public health measures and mutual recognition of vaccination certificates to facilitate air travel recovery. CAAs could also take a more cooperative and proactive stance towards industry, to lessen regulatory burden.

Conclusion

8 CAAS and LACAC reaffirmed their mutual partnership and support during these unprecedented times. Singapore will continue to work with LACAC to deliver in-person and virtual training programmes, with fellowships for the LACAC region. This will include a new ICAO-Singapore Directors-General of Civil Aviation Programme on Aviation Recovery, targeted for launch in 2022. Singapore and LACAC will also renew the LACAC-CAAS MOU for the next three years from FY22/23 to FY24/25.
