

ICAO Training Package: Oversight of Aircraft Leasing Operations

This course provides you with the competencies to design and implement operational processes and procedures for acceptance, approval and oversight of aircraft leasing arrangements in accordance with Chicago Convention and its Annexes in particular ICAO Annex 1, Annex 6 Part I, Part II, and Part III and Annex 8; as well as ensure the various leasing arrangements are in compliance with the State's regulatory framework.

WHAT YOU WILL LEARN

Upon completion of this course, you will be able to:

- Develop processes and procedures to recognise, accept, approve and oversee operations with different cases of aircraft leasing arrangements.
- Implement oversight procedures for different cases of aircraft leasing arrangements.
- Identify various categories of aircraft leasing and their implications on States and AOC holders' responsibilities with respect to personnel licensing, aircraft operations and airworthiness.
- Identify necessary regulations and procedures to ensure compliance with Chicago Convention and its Annexes for various cases of aircraft leasing.

WHAT IS COVERED

- Evaluating air operator leasing arrangements application
 - Types and conditions of various aircraft leasing arrangements
 - Responsibilities of State of Registry and the State of Operator in leasing arrangements
 - Requirements and conditions for acquiring a leasing arrangement
 - Schedule of events and duration in the approval of aircraft leasing
 - Suitability and application of Article 83 bis in aircraft leasing
- Approving proposed air operator leasing arrangements
 - Inspections of flight operations, licensing and airworthiness technical documentation
 - Operational arrangements and maintenance operations required for inspection/demonstration
- Inspection and surveillance of air operator leasing arrangements
 - Standard procedures for conducting operations inspection
 - Risk-based surveillance plan and organisation risk profiling of lessor and lessee
 - Resolution of safety issues related to aircraft leasing arrangements

- The learning activities of the course contain two types of activities:
