Speakers

Session: Operational Safety Management in Airlines



Nicholas Reyes, Moderator

Nicholas Reyes is the FAA Director, Western Hemisphere, Office of International Affairs (API) with base in Panama City, Panama. As the Director, Western Hemisphere Office, he is responsible for promoting U.S. interests and advancing civil aviation safety, security and efficiency.

Previously, he served as Manager of the Southwest Certificate Management office and the Dallas Fort-Worth International Field office. Mr. Reyes is a former U.S. Airways and American Eagle airline pilot. He served in the military as a Flight Examiner/Pilot with the Puerto Rico Air National Guard and the Texas Army National Guard.



Captain Helena Cunningham

Captain Helena (Reidemar) Cunningham is currently the Central Air Safety Chair for Delta ALPA. She has held the position of Director of SMS at ALPA, prior to that she held the position of Director of Human Factors for six years in the ALPA Air Safety Organization . She was appointed as IFALPA Safety Management Working Group Chair in 2021 and in that capacity her group serves as advisor to the ICAO SMP Annex 19. She is currently a Captain of the Boeing 767-400 at Delta Air Lines.



Capt. Juan Carlos Gonzalez Curzio

For 39 years, served as AeroMexico Pilot, flying experience 24 700 flight hours, currently B787 Captain, TRI/TRE on B787 type. USC graduated on Aviation Safety and Accident Investigation. Regional Vice President SAM North. Expert in leading global safety processes, strong projects management with organizational skills. Active participation in ICAO Safety Working Groups such as Regional Aviation Safety Group – Pan America (RASG-PA), Pan America — Regional Aviation Safety Team (PA-RAST), CAR/SAM Planning and Implementation Regional Group (GREPECAS), promoting safety initiatives and activities with the involvement of all civil aviation stakeholders to towards achieving the highest level of safety in the Pan American Region.



Capt. Alvaro Pereira, Copa

Álvaro Pereira, for 21 years worked in the Bolivian flag line LLoyd Aéreo Boliviano (LAB), the first 5 years as a specialist technician in engines and line operation; he later served as a pilot.

Rick was instrumental in creating, training, and inaugurating the ASAP program for our Aeromexico partner, a project that included working with the Aeromexico management, government regulators and the pilot union. He has also served extensively in the Delta pilot union, ALPA. His service for the union focused on International Affairs and Alliances, Strategic Planning, codeshares, negotiations, and as the Administrator for the national ALPA headquarters.
