Terms of Award

Upon acceptance to the courses, participants will have their training fees fully covered by the UAE GCAA.

For in-person courses, the following additional benefits will be provided:

- Hotel accommodation will be arranged for the duration of the training, including one day before the course commencement and one day after its conclusion.
- Participants will receive a daily allowance of 150 AED per training day, covering expenses during the entire course duration from the first day to the last.
- Roundtrip tickets will be provided for the duration of the course.

Application Guidelines:

Member States (CAAs) can nominate a maximum of one (1) candidate per in-person course and up to five (5) candidates for virtual courses.
