



United Arab Emirates GCAA 2026 Fellowship Training Program for International Civil Aviation Organization (ICAO) Member States

The Memorandum of Understanding (MoU) on Technical Cooperation between the General Civil Aviation Authority of the United Arab Emirates (GCAA) and the International Civil Aviation Organization (ICAO) stipulates the establishment of a Fellowship Training Program. This program aims to provide training and qualification opportunities for employees from Member States, contributing to capacity building and the exchange of expertise in accordance with international best practices.

Terms of Award

Upon acceptance into the courses, the General Civil Aviation Authority (GCAA) of the United Arab Emirates is pleased to fully sponsor the training fees for participants.

As the 2026 Program is currently planned to be delivered virtually by the GCAA, no travel or accommodation arrangements are required at this stage.

Should in-person courses be scheduled in the future, detailed participation arrangements and benefits will be communicated accordingly.

Application Guidelines

1. Civil Aviation Authorities (CAAs) of Member States may nominate qualified candidates for virtual courses based on their training needs and course relevance. There is currently no limitation on the number of nominees per Member State.
2. All applications must be submitted through the dedicated online registration links provided in the attached schedule.
3. Registration for virtual courses must be completed exclusively via the designated online link. No additional forms are required.
4. Should in-person courses be introduced, nomination limits and any additional registration requirements will be communicated in due course.

Note: Upon successful completion of the training and submission of the required feedback, the GCAA will issue a certificate, which will be sent to the email address provided during registration.
